



#### **Article 1: General**

Acceptance of training services from ttl.be implies adherence to the following terms and conditions. Any commitments made by ttl.be employees are considered valid only upon confirmation by its management. Direct deliveries from subcontractors are subject to their respective terms unless expressly stated otherwise.

## **Article 2: Training**

ttl.be specialises in providing ISTQB® and tailor-made training services.

#### **Public Sessions**

Are scheduled, allowing anyone interested to enrol on selected dates throughout the year. Public sessions are organised in live classrooms at the premises of ttl.be or live virtual classroom formats.

### **In-company Sessions**

Are scheduled and organised in close collaboration between ttl.be and the training client. In-company sessions can be organised with Live Classroom or Live Virtual Classroom format.

Dates and location are agreed upon between ttl.be and the client.

Please note that the ISTQB® Certified Tester Foundation Level Certificate is a prerequisite for all other ISTQB® certification training.

## **Article 3: Prices**

The prices for training services provided by ttl.be are outlined in the quotation, order form or purchase order and do not include VAT unless otherwise specified.

Additional costs, such as travel or logistic expenses, may be applicable and will be invoiced as agreed upon between ttl.be and the client.

## **Article 4: Payment Terms**

An invoice will be sent based on the signed order form or purchase order. Payment in full for training courses is required upon enrolment and before the start of the training course. ## **Article 5: Cancellation Policy**

#### **Public Sessions**

Participants of the open-format training must provide written notification to ttl.be in the event of cancellation.

- Cancellation over 2 months before the course: 25 % of the course fee is due.
- Cancellation within 1 month of the training: 50 % of the course fee is due.
- Cancellation within 2 weeks of the training: 100 % of the course fee is due.

The exam fee (if applicable) is not refundable in any of these cases.



## **In-company Sessions**

Cancellation for the in-company training format is only possible with written notification to ttl.be.

## Cancellation of the complete training

- Over 1 month before the course: 50 % of the course fee is due.
- 2 weeks before the course: 100 % of the course fee is due.

## Cancellation of individual participants

2 months before the course: 25 % of the individual course fee is due.

1 month before the course: 50 % of the individual course fee is due.

2 weeks before the course: 100 % of the individual course fee is due.

Please note that the basic training fee will be due even if participating with less than 5 people.

The exam fee (if applicable) is not refundable in any of these cases.
